The section of your Policy 'Restrictions on the use of the vessel' can be extended to cover one or more of the following extended navigation limits. These extended navigation limits are subject to additional premiums, and only apply if they are shown under the coverage Section A of your Pleasurecraft Form.

In addition to any conditions specific to the Individual extended navigation limit, the following applies to all extended navigation limits:

Excluding loss or damage caused by or resulting from a named windstorm unless you can evidence you are in compliance with the following requirements for the period June 1st to November 1st of the policy year in question:

- a) You have a hurricane plan showing a named yard where vessel kept.
- b) Named yard has agreed to carry out your hurricane plan.
- c) Hurricane plan includes haul out of vessel & securing to in-ground anchors, or storage of the insured vessel within a designated hurricane resistant storage building.
- d) Hurricane plan includes removal of all sails & canvass if vessel stored outside.

Where cover provided for loss or damage caused by or resulting from a named Windstorm, a deductible of 10% of the Insured Value applies to all partial, actual total or constructive total losses. This deductible reduces to 5% if your hurricane plan has been executed.

Named windstorms are those named by the National Oceanic and Atmospheric Administration.

**Extended Navigation Limit 1**

The Atlantic coastwise waters, intra-coastal waters and inland waters between the St. Lawrence River and Key West, Florida, including the Dry Tortugas and the Gulf Coast not beyond Cedar Key.

This Navigation Limit is subject to the following conditions:  
Excluding the St-Pierre & Miquelon Islands.  
Excluding Navigation more than 150 miles offshore.

**Extended Navigation Limit 2**

The "Mississippi Inland Waterway" and the coastal and Gulf Intra-coastal waters from Louisiana to Florida. For the purpose of this Extension, the term "Mississippi Inland Waterway" includes the Ohio River, Tennessee River, Cumberland River, Black Warrior River, and Tombigbee Waterway.

This Navigation Limit is subject to the following conditions:  
Excluding Navigation more than 150 miles offshore.

**Extended Navigation Limit 3**

Gulf of Mexico.

This Navigation Limit is subject to the following conditions:  
Excluding Cuba and Haiti.  
Excluding Navigation more than 150 miles offshore.

**Extended Navigation Limit 4**

The Island of Bermuda.

**Extended Navigation Limit 5**

The Bahamas Islands including the waters surrounding the Turks and Caicos Islands.

This Navigation Limit is subject to the following conditions:  
Excluding Cuba and Haiti.  
Excluding Navigation more than 150 miles offshore.

**Extended Navigation Limit 6**

The North and Eastern Caribbean Sea from the Turks and Caicos Islands to Trinidad and Tobago.

This Navigation Limit is subject to the following conditions:

Excluding Cuba and Haiti.

Excluding Navigation more than 150 miles offshore.

Excluding loss or damage caused by or resulting from a named windstorm unless the insured vessel is South of 14' North.

**Extended Navigation Limit 7**

The Southern Caribbean Sea Including Venezuela, the Lesser Antilles and Colombia.

This Navigation Limit is subject to the following conditions:

Excluding Navigation more than 150 miles offshore.

In respect of Venezuela and Colombia, cover excludes Theft, Piracy & Hijack absolutely.

Excluding loss or damage caused by or resulting from a named windstorm unless the insured vessel is South of 14' North.

**Extended Navigation Limit 8**

The Western Caribbean Sea from Panama to the Gulf of Mexico, not including the Panama Canal.

This Navigation Limit is subject to the following conditions:

Excluding Cuba and Haiti.

Excluding Navigation more than 150 miles offshore.

Excluding loss or damage caused by or resulting from a named windstorm unless the insured vessel is South of 14' North.
